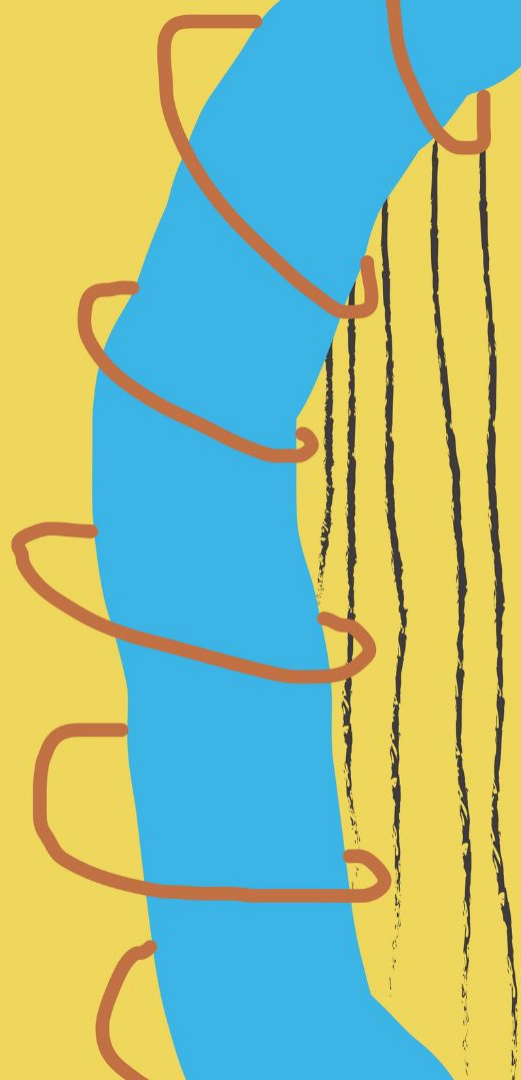

Partnership Pathways: Clinical vs. Facilities

There are two partnership pathways available at The Mind Room.

Clinical Partners

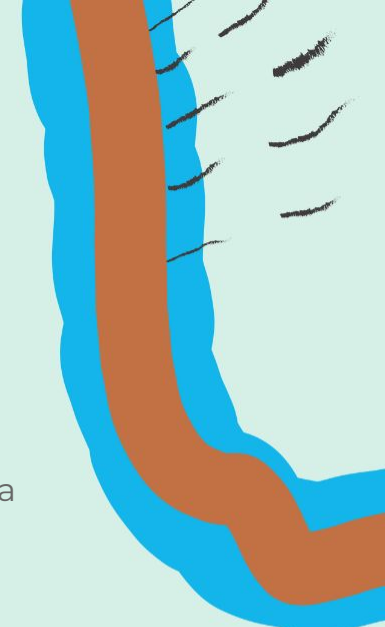
A Clinical Partner operates as an independent contractor under a Services & Facilities Agreement (SFA), maintaining clinical independence while receiving comprehensive operational, administrative, and professional support from The Mind Room for a variable service fee.

Includes access to monthly professional development sessions, peer supervision, reflective practice.

Facilities Partners

A Facilities Partner acts as an independent business owner under a Facilities Agreement (FA), renting a consulting room on set days and times to focus on client care while managing all other aspects of their business for a set facility fee.

Includes access to two professional development sessions per year.



The Clinical Partner Model: Role and Support

How we support you

We provide a supported clinical community so you can focus on client care and your wellbeing.

- A clinic leadership team providing professional guidance and support
- Operational support across reception, intake, finance, IT and administration.
- Thoughtful, well-matched referrals
- A variety of peer supervision, professional development and reflection sessions
- A warm, skilled and collaborative clinical community
- A light-filled co-working area, studio space, and a kitchen stocked with tea and coffee.
- 14 purpose-built consulting rooms and 3 telehealth pods
- Cloud-based systems — Halaxy, CoviU, Novopsyh and Connecteam.

Your role as a Clinical Partner

- You work with us as an independent contractor, not an employee, under a Services & Facilities Agreement (SFA).
- You hold full clinical independence — managing your caseload, availability and approach.
- You set your own fees and manage your own super, insurance and professional requirements.

The Clinical Partner Model: SFA, Fees & Invoicing

Services & Facilities Agreement (SFA)

Your SFA sets out the key parts of how we work together, including:

- **Your service fees** — what you pay for the support and facilities you use
- **Your consulting room access** — when and where you're allocated to work
- **Optional subscriptions** — like CoviU or Novopsych
- **Working expectations** — availability, communication and smooth clinical handover
- **Our commitments to you** — facilities and operations support

Service Fees & Invoicing

- Your service fee covers practice facilities, reception, intake, billing and other administration support.
- The fee percentage you receive varies based on the hours you commit each week.
- Room fees apply depending on your schedule (telehealth-only has no room fee).
- You choose your own subscriptions (e.g., CoviU, Novopsych).
- You receive a monthly statement on the 7th, outlining sessions and fees.
- Payments are processed from the 14th, with funds transferred within 5 business days.

- + **Online Management:** Our consulting rooms are shared spaces managed through a clear room-block system.
- + **Allocation:** Room blocks are allocated monthly so any changes can be communicated to clients with appropriate notice.

Our role in supporting you

We've created a calm, light-filled and green space so you can focus on client care. This includes:

- A welcoming, comfortable waiting area
- 14 purpose-built consulting rooms
- 3 private telehealth pods
- A shared co-working area and studio
- A kitchen stocked with good tea and coffee
- Access to two professional development workshops a year

Facilities Agreement

Your Facilities Agreement (FA) outlines:

- Your facility fee structure & subscriptions
- Your consulting room day and time allocation
- Our obligations to you in regards to facilities

Your role as a Facilities Partner

- You work with us as an independent business owner renting a consulting room on set days and times (ongoing/booked or casual).
- You hold full independence — managing your caseload, schedule and therapeutic approach.
- You manage all aspects of your business, including bookings, billing, fees, insurance and professional obligations.

Fee structure & Invoicing

- We charge a set fee based on your schedule and room selection.
- You will receive a monthly invoice outlining the facilities & subscription fees.
- Payments are due within one week.



The Facilities Structure: Ongoing vs. Casual

- + Keep all your booking and communications in one place.
- + **A \$15 monthly fee applies.**
